- Exchange studies for PhD students are organized according to individual plans.
- It is not possible for exchange students to defend their BA/MA/PhD thesis at the host university.

- 3. A Transcript of Records will be issued by the receiving institution no later than 4 weeks after the assessment period has finished at the receiving HEI.

For the purposes of calculating average grades of the academic record, the following values will be taken: suspense: from 0 to 4.9 points; approved: from 5 to 6.9 points; remarkable: from 7 to 8.9 points; outstanding: from 9 to 10 points.
